This initiative aims to strengthen youth and community-led advocacy and action, by understanding how global funding cuts are affecting children, adolescents, and young people living with or affected by HIV. Many young advocates may have completed Y+ Global's Global Survey in early 2025. The insights from this have helped to shape this new consultation. Now, we are asking young advocates to co-design our next advocacy initiative ahead of ICASA 2025, ensuring young people's perspectives are represented. This activity is for community advocates to have their say on the impact of the cuts to help us:

- Suggest how issues can be addressed
- Learn about upcoming advocacy opportunities
